- 1. The Company data supplied to Easy Innovations Ltd for your organisation has been received via completion of a Stockist Application form and/or Supplier Agreement.
- 2. All hard copies of this information is stored in a secure cupboard and is only accessible by relevant staff within Easy Innovations Ltd.
- 3. Electronic information is stored on our secure server, which is protected by a firewall, virus software and Watchdog application. These are all kept up to date by our computer specialist company, ADM Computing, Canterbury, Kent. Only Easy Innovations Ltd's staff have access to this information via secure login details and passwords, which are changed on a monthly basis.
- 4. When your Company places an order with us for stock, we will always contact the relevant branch and manually record the name of the person we speak to. This is done for the following reasons:
 - a. To verify the physical content and prices shown on the order;
 - b. To confirm the delivery address;
 - c. To confirm if any additional point of sale material is required;
 - d. To confirm when the order has been dispatched;
 - e. Advise of any delays or subsequent problems with the order.
- 5. Occasionally Easy Innovations Ltd will use the information we hold about your Company to contact you and/or your branches to advise about new offers and/or new products. You can opt out of this service at any time.
- 6. Your Company may have supplied us with a list of email addresses for branches which includes the name of the main contact at that branch.
